- Representative of M/s Audio Medics told that they attached their CDR with the financial bid.
- He also told that they made their CDR in accordance with their quoted cost instead of the total estimated cost given by the procuring agencies (i.e. the Children's Hospital Lahore).
- Said firm did not attach the bidding documents in their

REMARKS / DECISION OF GRIEVANCE COMMITTEE

Grievance committee examine the bid of M/s Audio Medics & it is revealed that on perusal of record said firm did not meet the knock down criteria.

- Bid security (2% CDR/Bank Guarantee) of the 1. estimated price which is mandatory part of tender mentioned in part-I, Sr. No. 4.of bid evolution sheet in bidding documents.
- Loose Bid: It is clearly mentioned in clause 2. No. 8

page No. 29 of bid invitation of bidding document which states that "All bids should be submitted in tape binding. Bids with loose papers or in ring binding shall All documents should be rejected straightaway. contain proper page marking, attached in sequence as indicated for evaluation in the bidding document and signatures of authorized person.

Moreover, signing and stamping of each page of bidding document/form is mandatory otherwise bid shall be rejected straightaway"

Hence grievance rejected
