M/s Electromec Engineering (Pvt.) Ltd. submitted their grievance against Technical Advisory Committee's decision relating to qualification of M/s National Industrial Engineers (Pvt.) Ltd. against tender (clause No. 1-b) valid Pakistan Engineering Council registration certificate of firm registration.

M/s Electromec submitted that M/s National Industrial Engineers (Pvt.) Ltd. do not have valid Pakistan Engineering Council registration certificate. NOTIFICATION

- 1. Keeping in view the COVID-19 driven difficulties, the Governing Body of Pakistan Engineering Council in its 42nd meeting held on September 7, 2021, has accorded approval to Relief Package for Constructors, Operators and Consulting firms/companies, as under:
 - a. Amnesty in Arrears for Renewal Cases of Constructors/Operators and Consultants.

The defaulting firms to pay current year's annual fee alongwith 10% of arrears.

b. Reduction in Penalty on Unauthorized Works.

As per existing PEC rules, firms are imposed penalty equal to three times of the annual fee of category desired by the firm, if it has undertaken a work without valid license. As one time relief, 25% of due penalty will be charged for all such works which had been undertaken without valid license.

c. Relaxation in Fee on Direct Registration in Higher Categories.

Presently, a firm applying for direct registration in C/O-3 and above categories is charged fee amounting to three times of the prescribed fee of desired category. In order to provide relief, only two times of prescribed fee of any desired category will be charged for new registration in C/O-3 and above.

- d. Fee for Multiple Steps Upgradation.
 - (l) One Step Upgrdation Single fee of desired category
 - (2) Two and more steps Upgradation 1.5 times fee of desired category
- e. Exemption of 01 Year Fee for Constructor/Operator Firms if Applying for Renewal for 03 Years

Exemption of one year fee will be granted to such Constructor/Operator and Consultant firms in all categories, who apply for Renewal/Renewal-cum-upgradation for consecutive 03 years.

2. This relief package shall be implemented with immediate effect and admissible to any case submitted <u>till October 31, 2021</u>. This relief would be admissible on said cases regardless of their disposal date.
