- 4. Sealed bids are required to be brought in person by the authorized representative of the interested bidder in the office of Medical Director, which will be opened in the presence of the authorized representatives of the bidders as per scheduled mentioned above.
- 5. Procurement shall be governed by the Punjab Procurement Rules 2014.
- Cost Estimate is Rs. 46,408,032/- per annum, Bid Security 1% Rs. 464,080/- for one year extendable for further three month or till the completion of codal formalities for the next contract subject to satisfactory performance and mutual consent.
- The bidders are required to furnish bid security is 01% of the estimated cost mentioned in bidding document is shape of CDR/Bank Guarantee/Pay Order/Demand Draft to the name of Medical Director, The Children's Hospital, Lahore along with the technical bid.
